

OBJECTS CAN BE REGISTERED AS TRADEMARKS

A trademark is a symbol, word, or words that are legally registered or established by use as representing a company or product. A trademark can be a name, word, signature, letter, figure, drawing, symbol, title, tax stamp, seal, image, inscription, advertisement, pack, or any other combination that is intended to be used for the same commercial purpose.



VALIDITY OF THE TRADEMARK REGISTRATION IN THE UAE

A trademark registration is valid for 10 years in the UAE, and the registration can be renewed for the same period.


TRADEMARK REGISTRATION REQUIREMENTS & PROCESSING

- An application for initial search must be applied to the Trademarks Registration office, they will conduct an initial search in order to see if registered before or not, if not:
- An application with all required documents including the image of the targeted Trademarks will be filed, and the fees must be paid.
- The Trademarks Registrar office will publish in 2 local newspaper about your application requesting for the trademark registration.
- Any interested party may file a notice of opposition to the registered trademark within 30 days from the date of any publication.
- The Registrar's decision about the opposition may be appealed to the ministry's committee and the committee's decision may be appealed to the competent court.
- In case if no opposition is lodged within the time limit above, a trademark is registered and a certificate of registration is issued.

DOCUMENTS REQUIRED

- A Soft copy of your Trademarks image in black & white.
- A Power of attorney appointing our firm to act and apply on your behalf.
- A Copy of the applicant Certificate of Incorporation (for corporate applicant only).
- A Copy of the applicant passport.
- Certificates of a Trademark registration if registered in any other countries.
- Legal translation- for the wording which might be included in your trademark. We require translation from your language of origin to English. The translation from English to Arabic will be handled by your agent Farahat & Co. Farahat & Co are not legalized to translate, and will therefore assign the task of translation to a locally regulated legal translator in the UAE.
